



## **COUNSELING PAYMENT INFORMATION**

The initial intake session will last approximately two hours and is billed at a total rate of \$90.

Additional sessions will last approximately one hour. Life In Abundance uses a sliding fee scale to determine the amount an individual, couple, or family group pays for a counseling session. In addition to the cost of each session, there is a one-time \$50 fee for each Temperament Assessment (APS) that is completed.

The following information is only used to calculate the amount to be paid for counseling. If you do not wish to submit the following income information, the cost will be \$75 per session.

### **Court Appearances and Depositions**

Life In Abundance is a non-profit ministry and any time that is taken away from the office and our clients creates a financial hardship for the ministry. Our policy is not to make court appearances or participate in depositions. In the event that any counselor, coach or staff member is required to make such an appearance or complete a deposition, the following billing rates will apply:

- \$350 per half day (0-3 hours)
- \$700 per day (3-6 hours) with a \$350 minimum

### **Records Subpoena**

Life In Abundance is a non-profit ministry and any time that is taken away from the office and our clients creates a financial hardship for the ministry. In the event that any Life In Abundance records are subpoenaed for a court case, the following billing rates will apply:

- \$500 file preparation and administrative fee

### **Affidavits**

Life In Abundance is a non-profit ministry and any time that is taken away from the office and our clients creates a financial hardship for the ministry. In the event that any counselor, coach or staff member is required to complete an affidavit, a minimum fee of \$100 will apply.
